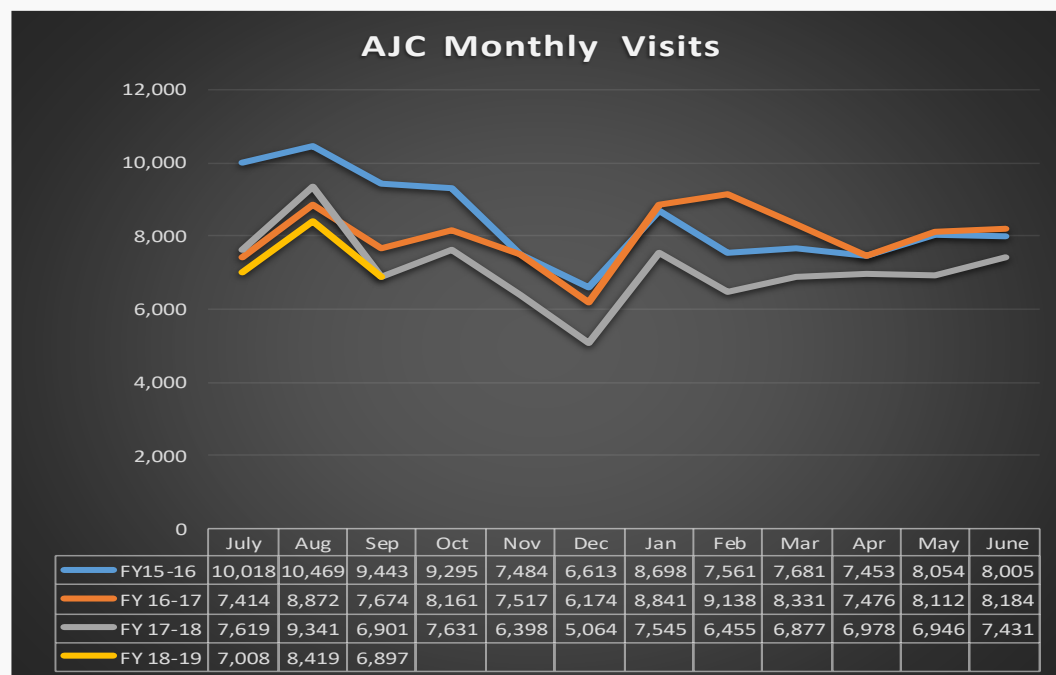


AJC Visits



Things to note:



- The monthly average traffic in former LWDA 8 is 6,976 for the first quarter of the FY 2018-2019.
- Seven Affiliate Centers host 52% of visits, and the two Comprehensive Centers host 48% of visits.
- The former LWDA 8's largest and busiest facility is the Clarksville AJC, which has served 7,661 through the first three months of the program year, averaging 2,394 per month.

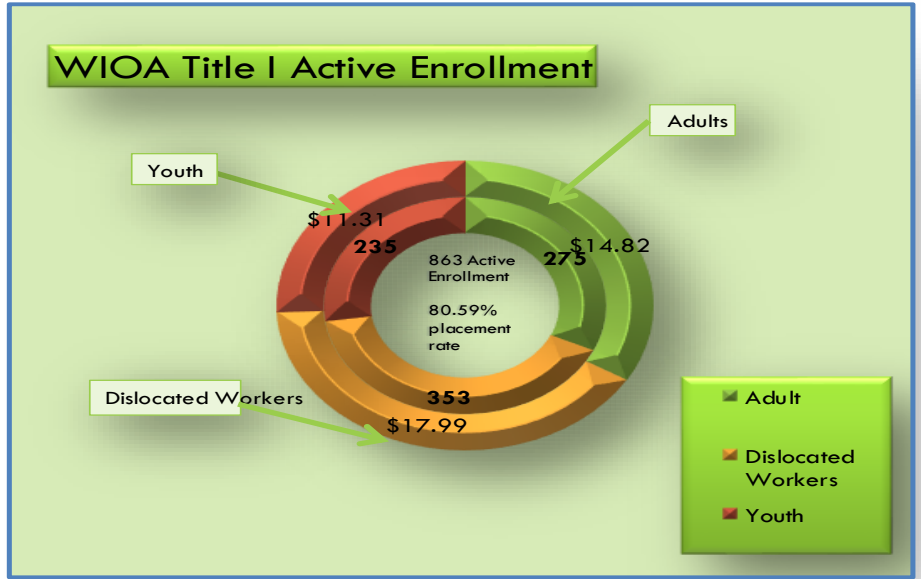
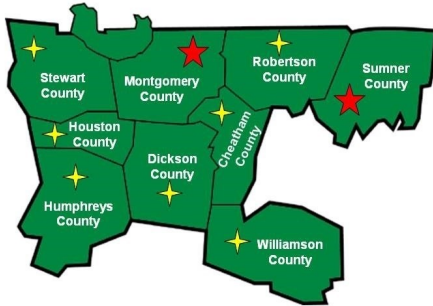
