## **Local Area Updates**


The first two months of the quarter that began on Jan 1, were very productive. There was a nearly 19% increase in foot-traffic in all of our American Job Centers (AJCs) across our thirteen counties, compared to the first two months of the previous quarter. Things changed in March. First, the March 2 tornadoes knocked out power to the Davidson County AJC for a week. But many of the staff from the Nashville, Sumner and Wilson County AJCs sprung into action for Tornado Relief efforts, working on Saturdays and Sundays also, on the mobile AJCs to help process displaced workers due to Tornado Damage.

As Tornado Relief was winding down, the COVID-19 pandemic hit, forcing all of our AJCs to be closed to the public just after mid-March. Northern Middle led the way for the state and began the re-opening process on May 11.




#### **AJC Total Traffic Counts**

# Northern Middle AJC Report January 1, 2020 - March 31, 2020

Like the rest of the state and the rest of the country, the Northern Middle Tennessee Local Workforce area has been hit hard by the COVID-19 pandemic. Unemployment rates have more than quadrupled across our area.

Yet unlike other local areas in the state, our American Job Centers (AJCs) never completely closed. From mid-March through early May, our AJCs were closed to the public but many of our staff were inside working while others were working from home; serving our clients virtually and over the phone.

On May 11, all Title I staff reported back to our AJCs for Phase I of our re-opening to serve our clients on an appoint-only basis. May 26 began Phase II, which meant we opened our doors to the public on a very limited basis depending on building capacity. June 8 saw us go fully operational, while still observing CDC Guidelines. Other local areas are still in their planning stages, while our AJCs are committed to serve our local job-seekers in this crisis.

#### Performance During COVID-19

The first two months of 2020, saw high levels of productivity in our AJCs. Foot traffic and Title I enrollments were up and things seemed to be setting up for a good 2020. Even the tornado in early March seemed to have little effect on performance. But when the COVID-19 pandemic hit in mid-March, our AJCs were closed to the public, at a time when unemployment was suddenly soaring. While our TN Department of Labor partners were focused exclusively on Unemployment Insurance (UI), the rest of the AJC staff was directed to answer phones and help them ion any way possible. Still, the Title I staff was keeping an eye on helping provide Title I service to those who needed it. While virtual enrollments were possible for some, they weren't for others. That is why it was imperative that our AJCs opened sooner than later. Below is a comparison of new Title I enrollments for the quarter ending March 31 (left) and for the two months of April and May during the pandemic.
